





Data Notes

- HSFS data reflects information that states and territories have reportedly <u>documented</u> without estimation. As a result, data reported by CDC EHDI may differ from other sources.
- Some respondents <u>only</u> provided partial data (e.g. hearing screening data only). As a result the number of reporting states and territories and denominators varies for some of the data sections.
- This data is subject to change if additional states and/or territories report data for year 2012.
- In Process: Respondents were advised that to be reported in this category each infant <u>must</u> have been seen for diagnostic testing at least one time and have a follow-up appointment already scheduled.
- LFU (Loss to Follow-up) / LTD (Loss to Documentation): Sub group of "No Documented Diagnosis / Undetermined" and "No Intervention Services." Includes instances where infant's families were Unable to be contacted or Unresponsive, and Unknown cases.

Explanation of 2012 Calculations

Documented Hearing Screening (based on data from 57 States & Territories)

Percent Screened 3,820,624 (# screened) / 3,953,986 (occurrent births reported by EHDI programs) x 100 = 96.6%

Percent Screened (*excluding infant deaths & parental refusals*) 3,820,624 (# screened) / 3,933,508 (occurrent births *excluding infant deaths & parental refusals*) x 100 = 97.1%

Percent Screened Before 1 Month of Age 3,287,614 (# Pass and # Not Pass before 1 Month of Age) / 3,820,624 (# Pass + # Not Pass) x 100 = 86.0%

Percent Not Passing final / most recent hearing screening 60,760 (# not pass) / 3,820,624 (# screened) x 100 = 1.6%
