- The Combined Immunization
 Schedule WG updates the immunization schedules annually.
 - Child and adolescent schedule
 (age birth through 18 years)
 - Adult schedule (age 19 years or older)
- The schedules are primarily designed to be a tool for healthcare providers to ensure individuals get all the vaccines they need when they need them.

Combined Immunization Schedules Work Group


- The goal of the Combined Immunization Schedule WG is to better harmonize the child/adolescent and adult schedules.

Impacts of Timeliness of Schedule Publication


Insurance reimbursement
