**Vaccine Code Set Update Publication Date: July 10, 2025**

**Release Notes:** Release notes provide a technical summary of the updates made to vaccine code sets and crosswalks. This code set release includes updates for all regular vaccine-related codes. It does not include updates to other Vaccine Information Statement (VIS) codes.

**General note regarding this release:** Codes with “Last Update” dates from May 03, 2025, and before July 04, 2025, reflect the changes and additions in this release.

### Vaccine Code Set Updates – Details

#### 1. New RSV monoclonal antibody (clesrovimab-cfor) product: new CVX, NDC, CPT, Product codes and crosswalks added for ENFLONSIA

Monoclonal antibody codes are included in the vaccine code set in a manner similar to regular vaccines to enable reporting or other data exchange in accordance with ACIP and CDC guidelines. The Merck product ENFLONSIA (clesrovimab-cfor) is a monoclonal antibody product approved by the FDA and available as per ACIP and CDC for reporting.

In addition to the new codes shown in the table above, the following codes and crosswalks have also been added:

- CVX code 332 is associated to Vaccine Group “RSV”.
- A new CPT code 90382 has been added; Short Description “MONOC ANTB SEASN .7ML IM”, Long Description “Respiratory syncytial virus, monoclonal antibody, seasonal dose, 0.7 mL, for intramuscular use”. CPT code 90382 is associated to the above NDCs and CVX code 332.
- A new product table entry has also been added, “ENFLONSIA” and is associated to CVX code 332 and MVX code MSD.

#### 2. New NDC codes and crosswalks for M-M-R II relabeled product from A-S Medications

New NDCs have been added to the vaccine code sets. Mappings to CVX, MVX, and CPT codes have been added as noted below.

### 4. CVX code for oral polio vaccine (OPV) updated short description and note field

CVX code 02 for historic oral polio vaccinations (OPV) has been updated. The short description is updated to add the word trivalent in order to better differentiate it from the unspecified vaccine CVX code 182, “OPV, Unspecified”. The note has also been updated to provide greater clarity regarding the trivalent OPV product’s use timeframe.
