Vaccine Code Set Update – Details

1. COVID-19 2025 Fall Codes and Crosswalks

On August 27, 2025, the FDA approved the Fall 2025 COVID-19 vaccines. All COVID-19 vaccines are now approved under BLA licensure. Prior Fall 2024 COVID-19 vaccines are to be retired. The FDA has revoked all Emergency Use Authorizations (EUA) for COVID-19 vaccines effective 08/27/2025.

CDC has replaced the Fall 2024 COVID-19 Vaccine Code Sets and Crosswalk table with a Fall 2025 COVID-19 Vaccine Code Sets and Crosswalk table that includes all of the COVID-19 vaccines approved by FDA on 08/27/2025. The Fall 2025 COVID-19 Vaccine Code Sets and Crosswalk table provides a preview of the core code and crosswalk information ahead of CDC's full vaccine code sets publication. The new NDCs, the tradenames mNEXSPIKE and NOVAXOVID, the new CVX code 334 for mNEXSPIKE, and the new CPT code 91323 for mNEXSPIKE, are not yet available in CDC files. A subsequent vaccine code set release will be published with the new and retired COVID-19 codes and other updates.
