### **2025 Data Year Close-Out**


The following table includes the 2025 contract closeout and draft 2025 file release dates. Note that to include a jurisdiction's most current information in the file release, all corrections and final file deliverables are due no later than the target dates listed. The target

dates are highlighted in red, as are the contract closeout dates and the dates for final updates. The dates for final updates are subject to change and may be earlier, depending on the quality of the national file. (Provisional birth data cuts are no longer provided as CDC Wonder will be the source of provisional data.)

Notable Publications/Data Briefs

Fetal Mortality in the United States: Final 2022–2023 and 2023–Provisional 2024



This report was published in December and can be found at this link [Vital Statistics Rapid Release, Number 041 \(December 2025\)](#). The report found that Between 2023 and 2024, the fetal mortality rate declined 2%, from 5.53 to 5.41 fetal deaths at 20 weeks

of gestation or more per 1,000 live births and fetal deaths. During this time, the early fetal mortality rate (20–27 weeks of gestation) was essentially unchanged in 2024 at 2.88, while the late fetal mortality rate (28 weeks of gestation or more) declined by 4% to 2.55 in 2024. No significant changes in fetal mortality rates between 2023 and 2024 were observed among the race and Hispanic origin groups. Fetal mortality rates decreased in three states, increased in one state, and were not significantly different for 46 states and the District of Columbia from 2023 to 2024.

## Vital Statistics Modernization Community of Practice



The **Vital Statistics Modernization Community of Practice (NVSS COP)** is a collaborative space for learning and innovation. It provides a setting for jurisdictions and their partners to collaborate in the modernization space.

As we close out 2025, here is an at-a-glance overview of the NVSS Modernization community's progress towards modernizing and strengthening vital records. Vital records offices (VROs) achieved this through participation in NCHS testing, certification, and production activities. These maps highlight how jurisdictions across the country are engaging in organized testing events, advancing through FHIR pre-certification, completing full certification, and ultimately moving into live production with FHIR-enabled mortality reporting. As shown, participation continues to grow, with more states progressing through each milestone—reflecting steady nationwide momentum toward faster, more accurate, and more interoperable mortality data.



In addition to the progress with mortality reporting, there has also been early progress in natality and fetal death testing as part of NCHS-organized events. While participation is still in its initial stages, several jurisdictions have already stepped forward to engage in these important testing activities. For fetal death, four jurisdictions—including Wyoming, New Hampshire, Vermont, and American Samoa—have participated so far. Natality testing has had slightly broader involvement, with seven jurisdictions, including Washington, Utah, Wyoming, New Jersey, Delaware, American Samoa, and Rhode Island joining the effort. This growing engagement marks an encouraging end to the year as more jurisdictions begin to test and prepare for future FHIR-enabled reporting improvements across vital events.
