Locating Resources to Submit Data

Facilities can submit data in three different ways:

1. Entering **summary-level** data directly into data entry screens
2. Uploading .CSV files of **summary-level** data
3. Using **Person-level** COVID-19 Vaccination Forms (COVID-19 vaccination data only)
 - a. Entering data directly into the Person-level forms
 - b. Uploading .CSV files of Person-level data

Method 1: Entering Summary-level Data Directly into Data Entry Screens


Overview

Nursing homes report COVID-19, influenza, and respiratory syncytial virus (RSV) data weekly to CDC's National Healthcare Safety Network (NHSN), including vaccination, cases, and hospitalizations among residents. Nursing homes also report COVID-19 vaccination data among healthcare personnel (HCP) to NHSN monthly. This page displays data among residents and HCP of CMS-certified nursing homes. These national and state-level summaries represent data from approximately 15,000 nursing homes that report to NHSN.


Nursing Home Respiratory Pathogens Data Dashboard (cont.)

The below steps serve as a guide for Long-term Care Facilities (LTCFs) enrolling in the National Healthcare Safety Network (NHSN).

Once a facility is registered with NHSN, users can then continue with the NHSN enrollment process for the facility using a SAMS authentication token. This requires the installation of an Entrust Authenticator application on a device or a hard token which is a physical Entrust grid card mailed to your home address. If the designated NHSN facility user has not previously registered with SAMS and received an authenticated token, the user must complete the identity verification process with SAMS prior to gaining access to continue with the NHSN enrollment process for the facility.

A facility should only enroll **once** into the LTCF Component. Once a facility is enrolled, additional options become available, such as adding additional users and enrolling in additional Components.

Step 1: Enrollment Preparation




